Tolani Lake Enterprises Inc received a 3.4-million-dollar grant from Navajo Department of Water Resources as a subrecipient to manage the funds for the Former Bennette Freeze Area. December 8 to December 28, 2020 we were able to drill 14 wells along the Little Colorado Valley, set up 3 hoop houses. 200 roof top water catchments. My job entailed getting the permission to survey documents and the Tribal Access Authority for the water wells from Navajo Land Department. I had to work with Chapters, Grazing Officials and Navajo Nation Departments.

Helped Navajo THAW, Building Communities, Navajo Builder form Native Promos a 501c3 non-profit organization. The community view at the chapter level is the Navajo Nation's procurement process is too lengthy and sometimes does not work. The non-profit fiscal money management is better and faster for communities to work with. Tolani Lake Enterprises Inc is a good organization but is overwhelm with projects and Native Promos will be there to help.

CAMERON FARM ENTERPRISE 2017 TO PRESENT

Worked with Tolani Lake Enterprise to form the Cameron Farm Enterprise Inc. Cameron wanted a local working group to look into how the Cameron Community can benefit from Little Colorado River for food and water security. Cameron Farm Enterprise is in the process of withdrawing 400 acres to grow food, water for livestock, water for wildlife and some filtration for domestic use.

CAMERON AGRICULTURAL AD HOC COMMITTEE 2017 TO 2020

Helped establish the Cameron Agricultural Ad Hoc Committee, during a Cameron Land Use Planning meeting report the subject came up about former Cameron Farm Project back in the late 70 and early 80s. I was found that 150 thousand acer feet of water flow down the Little Colorado River annually. The Navajo Tribe and Hopi Tribe cannot determine how much water is used for farming, livestock use and drinking water. The little Colorado River water and the Blue Springs just below the little Colorado River and the Colorado confluence together about 315-thousand-acre feet of water flow into the Colorado River. The Chapter decided to form an Ad Hoc Committee to address the situation and come with a plan to mitigate the situation.
